### 8 Green New Years Resolutions

### 1. Recycle More

Beyond the obvious recycling of aluminum, cardboard, paper, plastic, and so on – what items around your home or facility can be re-purposed or given to someone else who can use them instead of putting them in the trash? Think simply, but creatively (i.e. composting, art projects, etc) and you may find the perfect fit! Try to reduce the amount of trash you throw out.

### 2. Buy (or Grow) Natural Foods

Eat more seasonal fruits, vegetables and whole grains preferably locally grown when you can. Avoid the "boxed" processed foods and lean towards foods that come from the earth. Local organic foods will be free of pesticides and also don't take so much energy to get to you.

### 3. Use the Re-Usable Shopping Bags.

In order for the reusable shopping bags to do any good, they have to be used! Find a way to remember to bring the earth-friendly bags with you to the store (keep them by the door or in your car) and reduce the number of plastic bags that you waste.

### 4. Think Local

Doing business locally not only helps our local economy to bloom, but also reduces the carbon footprint we are making on Mother Earth. Lessening your commute can save money, as well as provide more opportunities for walking or biking and getting in touch with the outdoors.

### 5. Do Second-Hand

Instead of buying books, borrow them from a friend or use the library. Second-hand clothes are money-savers and earth-friendly, especially for growing kids. When your kids outgrow their clothes, pass them on to a family in need, a thrift store, or find another way to recycle the clothing and textiles.

### 6. Teach Kids

Teach your kids about why it is so important to take care of our earth by leading by example and getting them involved. Sometimes they may teach us new things about the environment too. Be open to their ideas.

### 7. Do Green Business

Employees can put all their day-today environmental goals into hyper-drive at work too. Retail stores or factories may even consider purchasing a vertical baler for managing their recyclables or a busy mall or fast food restaurant may install an automatic trash compactor to minimize waste.

### 8. Be Water Smart

Buy a nice reusable water bottle and pledge to stop buying bottled water. Other ways to be smart about your water usage include collecting rain water, and simply minimizing water usage while brushing teeth and taking showers, etc.

Start with small easy tasks that can make a big impact when becoming a lifelong habit. Your 8 Green New Years Resolutions should be something that you can start simple, and build on.


We hope your NEW YEARS resolutions include spending time in your Trinity Library.



# The 2024 Simpson Forum, THE ETHICS OF CIVIC ENGAGEMENT

As an election year looms amid concerns about the serious divisions within our country, our communities, and our families, the Barbara and Justin Simpson Forum has announced its 2024 Forum, THE ETHICS OF CIVIC ENGAGEMENT, to address some of those concerns. The Forum is a 5-part series beginning at 7:00 pm on January 25 and continuing February 1, 8, 15 & 22, here at Trinity Lutheran Church. As in past years, the series will be presented live at Trinity and participants may attend either in person or on Zoom.

THE ETHICS OF CIVIC ENGAGEMENT will open with two lectures on the moral values taught in Old and New Testament scriptures. Presenters are Dr. Matt Skinner and Dr. Cameron Howard of Luther Seminary in St. Paul. Events 3 and 4 will feature Minnesota Supreme Court Justice G. Barry Anderson will address conservative moral values and Gustavus faculty member Dr. Peg O'Connor the liberal moral values that shape our personal political views. The 2024 series will conclude on February 22 with a case study exploring Minnesota's water issues and the division and interdependency that exist within the urban, suburban, and rural communities of our state. Pastor Jon Anderson, long-time Bishop of the SW Synod of the ELCA and current Luther Seminary faculty member, will make this final presentation.

### A. Business Discussed

### 1. Pastor Report

- It would be good to have the church all tidy for Christmas Eve services and plenty of help for ushering and greeting.
- Transitional Task Force (TTF) talked about the youth at Trinity and the need for a youth director.

### 2. Treasurer's Report

- The offerings as of November 30, 2023 were \$279,533.
- The total expenses through November 30, 2023 were \$301,548.
- Expenses exceed offerings by \$22,015.
- The checking account balance as of November 30, 2023 is \$36,717.

### 3. Financial Update

- Marc will do a Temple Talk to encourage year end giving.
- The Finance Committee has been working on a proposed budget for next year.
- Information about a cemetery donation was reviewed.
   More information will need to be collected and reviewed before a decision can be made.

### 4. New Business

Office Coverage – volunteers will cover the office hours while Kristen is on vacation.

Collection of offering – it was discussed to pass

the offering collection plates through the pews at Sunday services, but due to a shortage of ushers this is not feasible at this time.

<u>Building hours & church calendar</u> – the building hours follow the office hours that are posted. In addition, the church is open when there is an event scheduled on the church calendar. Please remember to contact the office if you have an event.

Newsletter Deadline – the deadline for the monthly newsletter is the 20th of the month.

Annual Meeting – It was agreed that the Annual Meeting be held January 21, with a backup snow date of January 28. **See Action Item 3**.

<u>Funeral Policy</u> – Trinity's funeral policy was reviewed to see if we are meeting current situations. The fees were reviewed and we are below others in the area. Current Funeral Policy fees are *With Funeral Director*. Organist - \$125; Pastor - \$125; Custodian - \$50; Funeral Serving Group - \$125 to \$150. *Without Funeral Director*. Organist - \$125; Pastor - \$175; Custodian - \$75; Funeral Serving Group - \$150 to \$175. **See Action Items 4 & 5 & 6 & 7**.

### 5. Old Business

<u>Building Keys</u> – Safety for people and property is a concern we have. The cost to rekey the church is significant and so it makes sense that the keys held by people other than staff be returned to the office. A notice has been posted to have building keys turned in by December 15. Reminder that the building is open for events that are on the church calendar. If there is need for other events/meeting, there is a 48 hour window needed for the custodian to accommodate special requests.

### 6. Committee Reports

<u>Property Committee</u>: The rental house has been fixed up and the renter will move in at the beginning of the year. They will get quotes for narthex improvements that need to be contracted out.

<u>Community Life</u>: Prepared devotionals and bags for the homebound members. Caroling planned for December 17.

<u>Children, Youth and Family</u>: They are requesting a full time Youth Director. **See Action Item 8**. Sunday School Christmas Program went well. Planning a Caroling event with Community Life. Ordering Bibles for Sunday School.

Worship, Music and Arts: New candles for altar have been ordered.

Mission: Donations for winter coats went well. About 50 teen hygiene bags for high school students were assembled and donated. They are dispersing Endowment funds to these institutions: \$500 to South Africa Vryheid Circuit; \$300 to MN Adult & Teen Challenge; \$500 to Lutheran World Relief; \$400 to St. Peter Free Clinic; \$250 to The Kitchen; \$500 to St. Peter Pastors' Association; \$300 to Partners in Housing.

Adult Education: Book studies are planned for upcoming year.

<u>Stewardship</u>: They sent out Thank You notes for members who returned their promise cards. Looking to express gratitude for different areas in upcoming year.

### B. Responsibilities Assigned:

 Council members are requested to assist with Christmas Eve services, greeting and other help as needed.

- Motion M/S/P to approve a fee of \$100 for Tech ser vices for funerals. This was not in the current policy,

but the Funeral Director listed this as \$100 fee.

- 6. Motion M/S/P to approve funeral fees for non-Trinity member to be doubled.
- 7. Motion M/S/P to approve a flat fee of \$1,000 for funerals without a Funeral Director in addition to the listed funeral fees.
- 8. Motion M/S/P to approved that the Council sup ports Children, Youth & Family committee in their request to create a full time sustainable Youth Di rector position.
- 9. Motion M/S/P to approve a motion to adjourn.
